### **Wedding Shoot with reception, 8 hour coverage. \$949.00**

Includes approximately 100-300 shots with 50 printed 8"x10" and one Low Resolution disk of all photos. Shoot must be within 50 miles of studio or added travel expenses will be incurred, see below. Shipping charges additional.

### **Digital Camcorder recording of wedding & reception \$499.00**

Includes 2 copies of DVD-R disks. You must have a DVD-R capable set top player or DVD-ROM drive to view. Price good only with wedding Shoot. Shipping charges additional.

### **Power Point slide show set to your favorite songs. \$129.00**

Includes 2 copies of slide show on CD-R disks. Your favorite songs must be furnished on a legal CD. You must have a computer with CD-ROM drive to view. Price good only with wedding Shoot. Shipping charges additional.

### **DVD-R slide show set to your favorite songs. \$129.00**

Includes 2 copies of slide show on DVD-R disks. Your favorite songs must be furnished on a legal CD. You must have a DVD-R capable set top player or DVD-ROM drive to view. Price good only with wedding Shoot. Shipping charges additional.

## **Print List**

Please make your choices for prints from the included low resolution disk, email or our web site. Make a list referencing the numbers and letters on the picture, the size and quantity you want printed of that shot.

You may have the photos printed in glossy or the estimated 80 year archival, premium heavy matte paper which is recommended. Please note your choice.

If you have a package deal you may also order additional photos beyond your package at the prices shown on the price list. You may also **substitute** some or all of your package sizes for the equivalent smaller/larger photos as follows:

1-8"x10" = one page of 9 wallets, 2.5" x 3.25", all same shot.

1-8"x10" = one page of 4 prints, 4" x 5", all same shot.

1-8"x10" = one page of 2 prints, 4" x 6", all same shot.

1-8"x10" = one page of two prints, 5"x7", all same shot.

2-8"x10" = one 10"x12".

4-8"x10" = one 11"x14".

5-8"x10" = one 13"x19".

6-8"x10" = one 16"x20".

**\*Please note that low-resolution proofs are created from the original RAW IMAGES and may require editing for lighting, contrast, etc.**

Photo proofs are usually created at low-resolution (reduced image size). The primary reason for low-resolution proofs is space on the media or quick upload time at my end and quick download time at your end. The original high-resolution images are often 2,100KB or larger in size, where the low-resolution proofs are generally between 50-120KB.

I try to find a happy balance between display quality and quick upload/download time, and this *sometimes* results in image pixilation to one degree or another. Any pixilation is a direct result of creating the proofs in a low-resolution (reduced image size) format and **nothing else**.

Approximately half the shots are cropped at my discretion for what I think is the best look for that shot. If you see a shot that you want expanded out or cropped down further just note the numbered photo and describe your request. Not all shots can be expanded but nearly all can be cropped and somewhat enlarged on the print size of your choice. Keep in mind the aspect ratio (i.e.: the ratio of the width of the image to its height) as this will change the look of the printed shot to fit the particular print size.

Also since all shots are in digital "Raw" format the color temperature and exposure are also a creative judgment on my part and can be changed. So if you want a "warmer" look, for example, just note what you have in mind and I will try and accommodate you.
